





Effective January 1, 2015 In accordance with the passage of IRP's Full Reciprocity (FRP) ballot, Georgia will no longer issue or renew IRP "Restricted" commercial vehicle registration credentials.



### Examples of current IRP "Restricted" commercial vehicle registration credentials:

- IRP fleets listed as "Restricted"
- IRP vehicles listed as "Restricted"
- IRP registration Cab Cards which ONLY list the State of Georgia.
- IRP Cab Cards listing "Agriculture/Fertilizer", "Farm", "Milk/Fertilizer/Crops", "Single Pole", or "Twin Beam."
- IRP Cab Cards which list a "Plate Nbr" beginning with the letters "IR".
- IRP apportioned License Plates that begin with "IR" listed on the license plate/tag.

### Actions to take at Motor Vehicle Division if continuing interstate operations with IRP registration:

- At time of regular IRP renewal, mark your fleet as either "Haul for Hire" or "Private \*."

### Actions to take at County Tag Office if discontinuing IRP and changing to intrastate/Georgia-only:

- At time of regular IRP renewal, contact your local County tag office to complete intrastate registration and receive Georgia-only commercial license plates (Trip Permit required if operating interstate with Georgia-only plates.)

**Definitions:**

- **Haul for Hire:** hauling other people's goods.
- **Private:** hauling persons or property by commercial motor vehicle, and is not for-hire.
- **Interstate:** operating outside of "base state"/crossing state lines.
- **Intrastate:** operating only within "base state."
- **Base State:** state in which registrant/applicant has ability to prove either established place of business or proof of residency.
